About the training

The training is a part of the Erasmus+ accreditation plan of CVS-Bulgaria for 2025 and co-funded by the European Union which includes two training courses (March and July) and one youth exchange (August), carried out under the title "Quality in Action".

The training "**Level Up: Raising Quality in Youth Projects**" will be focusing on quality standards and best practices in Erasmus+ projects. It will take place in Hotel Jeravna, Bankya/ Bulgaria between 26th March (arrival day) and 2nd April (departure day) 2026.

During the 6 working days we will organise our daily program in 4 sessions of 90 minutes, 2 in the morning and 2 in the afternoon, with a break in between. Each session has a thematic focus and is divided in different blocks. Breakfast, lunch, and dinner will be provided at the venue, and in some evenings there will be optional evening sessions with planned activities.

Our working methods will be based on the principles of non-formal education and experiential learning, creating a motivating environment for sharing and learning. You will often work in smaller groups to achieve the best results. All the methods will encourage active participation, creativity, initiative and responsibility for one's learning process.

Learning Goals

During the training you will have the possibility to:

- Develop your skills in writing successful project applications
- Get insights on quality standards and evaluation frameworks in Erasmus+ youth projects
- Learn different techniques and tools for managing quality KA1 and KA2 projects from best practices
- Collectively reflect on how to implement quality standards in your organisations, adapt them to your local contexts, and incorporate them into your regular youth work activities
- Understand the key quality elements and criteria for Erasmus+ accreditation and how to apply them in practice
- Discover the requirements and opportunities of the new programme period and prepare for future funding calls
- Enhance new partnerships and network collaborations

- You need to be a resident of an EU member states + North Macedonia, Serbia, Iceland, Liechtenstein, Norway, Türkiye
- You must be able to communicate in English (the working language of the course)
- You must be at least 18 years of age
- You need to attend the whole course duration (there is no possibility to make exceptions)

Meet the team


Svetozar Daskalov (Svet)



Travel, Food and Accommodation



Participants will buy their travel tickets following the information provided in the Info pack and will get travel reimbursement up to the budget limit after providing all necessary travel documents.



Breakfast, lunch and dinner will be provided according to the dietary needs of participant but mostly vegetarian following our sustainability policy. Coffee/tea breaks will be organised twice a day, providing also fresh fruits and snacks.



The accommodation will be organised in double or triple rooms which have a private bathroom, bed-linens and towels, and free Wi-Fi. There are many possibilities to enjoy the free time in the surroundings of the hotel.



Sustainability

The food we provide will be mainly vegetarian/vegan and locally produced. We organise our breaks trying to use mainly organic products and fair trade coffee and tea. We use recycled paper and avoid plastic in our trainings, as well as we encourage our participants to recycle.

We encourage you to use environmentally friendly transport known as "green travel" (bus, train, car-sharing) when possible. This is especially requested from participants coming from neighbouring countries and all those with good train/bus connections.

We aim to:

- create a safer and inclusive learning environment through group agreements, confidentiality principles, and respectful communication guidelines established together from day one ensure a supportive and judgment-free
- atmosphere where facilitators and participants work together to build trust, celebrate diversity, and create space for authentic sharing and experimentation.

At the end of the training course you will receive an Youthpass certificate.

Financial conditions

Thanks to the funding of the Erasmus+ programme this training has no extra participation fee.

Travel costs will be reimbursed up to the established cost limits upon completion of the training and providing all the necessary travel documents.

Travel compensation: actual bus/train/flight costs with a maximum as indicated in the table (distance calculated from the place of residence to Bankya, Bulgaria on [Distance Calculator | Erasmus+](#)).

Visa costs will be reimbursed if duly justified.

Provisional Program

The program flow and contents will reflect the learning goals of the project as well as the learning needs and proposals of the participants.

All sessions will be clustered in blocks while each session will have a specific thematic focus:

Pillar sessions - these sessions will be in the beginning and at the end of the training and will be connected to the initial introduction to the group, program, team building and final evaluation. These sessions are important to set the mood for working effectively together as a team and to close the experience and set the next steps after the training.

Raising Quality sessions are the main sessions related to the topics of the training: Erasmus+ program and its guidelines; tip and tricks for successful project applications; techniques and tools for ensuring quality in management of the entire project cycle of KA1 and KA2 projects; key quality elements and criteria for Erasmus+ accreditation

Level up sessions - These sessions will bring the gained competences to the practical level where the participants can work together and also adapt the knowledge and good practices into their regular youth projects and local contexts. Thus we also envisage space for networking.

Reflection time at the end of each day will give the participants opportunity to reflect on their learning in small groups.


Each day the participants will have some free time to explore the surrounding area and the local culture.
